Federal Direct Parent Loan for Undergraduate Students (PLUS) Request

The PLUS is available to the parents of dependent undergraduate students. A parent may borrow up to the total of the Cost of Attendance minus all financial aid and other resources received by the student.

The Federal Direct PLUS utilizes a Master Promissory Note (MPN). The MPN allows a parent to complete a note that, in most cases, is active for all subsequent PLUS for up to 10 years. Although the parent should not have to sign a new note for each new loan, the parent still needs to request the specific dollar amount to be borrowed and must authorize a credit check each academic year or semester.

If the parent borrower does not have an active MPN on file, he/she may complete one online at www.studentloans.gov. NOTE: The parent completing the PLUS Loan Request MUST be the same parent that signs and completes the MPN.
